Discussion or counseling on job/career options is intended to foster motivation, consideration of opportunities and informed decision-making. Specific to youth, realworld activities ensure that students recognize the relevance of a high school and post-school education to their futures, both in college and/or in the workplace. *Work-Based Learning Experiences *Work Based Learning (WBL) is an educational approach or instructional methodology that uses the workplace or real work to provide students with the knowledge and skills that will help them connect school experiences to real-life work activities and future career opportunities. It is essential that direct employer or community involvement be a component of the WBL to ensure in-depth student engagement. These opportunities are meant to engage, motivate and augment the learning process. These WBL opportunities can be done in conjunction with private, for-profit, public or nonprofit businesses in your community and/or through web-based resources. In addition, work-based learning requires in-depth engagement of youth and an evaluation of acquired work relevant skills.	LEA may connect students to unpaid work experiences. Self-Advocacy Instruction *Self-advocacy refers to an individual's ability to effectively communicate, convey, negotiate or assert his/her own interests and/or desires. Self-determination means that individuals with disabilities have the freedom to plan their own lives, pursue the things that are important to them and to experience the same life opportunities as other people in their communities. It means taking the responsibility for communicating one's needs and desires in a straightforward manner to others. The development of self-advocacy skills should be started at an early age. These skills will be needed in education, workplace and community settings. As requested by the high school, VR counselor will provide services along with PTC Denne Brodbeck on Wednesdays beginning in September. Services will be provided 2x a month and may be provided in .50 days as needed/students. VR counselor will make an effort to attend IEP's in person or virtually, when possible and will assist in obtaining consent forms and pre-ets from potential students/families and be available to answer parent questions about services. Counselor will work to collaborate with IA Works staff as needed or requested from school. Counselor will make an effort to communicate services without the usuage of confusing acronyms. VR counselor would like to explore the idea of a summer camp for pre-ets students at school and work based learning opportunities in the community.
