Dear Mr. Jurrens,

Thank you for contacting Brian Tenge of Henkel Construction regarding the weight room addition that you would like to build. This letter is intended to serve as a preliminary (schematic) design proposal and agreement. In the following paragraphs, I will outline our understanding of the project scope, the services we are to provide, and our proposed fee.

## **UNDERSTANDING OF PROJECT SCOPE**

New Hampton Community Schools would like to explore the addition of a weight room on the southwest portion of the current school as indicated in the attached illustration that you provided. This addition will be somewhere between 4,300 and 4,800 square feet.

## PRELIMINARY DESIGN SERVICES

The following <u>preliminary</u> design services will be provided by Accord Architecture:

- Two (2) schematic design meetings with school administration team
- Exploration of at least one design option
- Production of the following schematic drawings:
  - o Draw portion of existing school where new addition will attach to
  - New Floor Plan
  - o Exterior elevations
  - o Two (2) color 3D images of the exterior and one (1) interior 3D for visualization
  - o Preliminary/basic interior information as needed for preparation of cost opinion
  - o Preliminary code review

Excluded from this proposal at this time are the following services:

- Design Development Phase Services
- Construction/Bidding Documents
- Structural engineering
- Mechanical and electrical (MEP) systems design

- Hazardous material analysis or abatement, such as asbestos, mold or lead
- Any services not specifically stated as included above


## PROPOSED DESIGN FEE
