Board Proceedings

The Board of Directors for the New Hampton Community School District met in regular session, Monday, August 13, 2012 in the High School Media Center. President Anderson called the meeting to order at 6:30 pm with directors Rosonke, Denner, Rasmussen, Ewert, Superintendent Jurrens, and Board Secretary Ayers present.

Director Rasmussen moved to approve the agenda as published. Director Rosonke seconded the motion. Ayes: Ewert, Rosonke, Denner, Rasmussen, and Anderson. Nays: none.

Director Rasmussen moved to approve the consent agenda items: the minutes of the July 9, 2012 regular session. Approve the July 2012 monthly financial report and the August 2012 bill listing. Accept the resignation of Jeff Eichenberger (Head 9th Football) and Michelle Schwartz (cook). Appoint Dennis Pagel (Head 9th football coach), Terry Sittig (Asst. 9th football coach), Nick Hemann (Head 8th football coach), Jason Rude (Asst. 8th football coach), and Brad Schmitt (Asst. 7th grade football coach). Appoint Matthew Schult (Middle School Social Studies and Special Ed). Approve volunteer coaches Brandon Lenehan (Football). Wes Cleveland (Wrestling), Tom Fye (Wrestling), Ron Underwood (Trapshooting), Lynn Schwickerath (Trapshooting), Bob Holschlag (Trapshooting), Chuck Stanton (Trapshooting), Cubby Schmidt (Trapshooting), Eric Schmidt (Trapshooting), Patty Phillips (Trapshooting), Brenda Holschlag (Trapshooting), Jeff Eichenberger (Football, Basketball, and Softball). Linda Kennedy will be recalling two full time and one part time para-educators. Director Denner seconded the motion. Ayes: Rosonke, Ewert, Denner, Rasmussen, and Anderson. Nays: none.

Following discussion of Board Policies 800 (Objectives of Buildings & Sites), 801 (Site Acquisition and Building Construction), 801.1 (Buildings & Sites Long Range Planning), 801.2 (Buildings & Sites Surveys), 801.3 (Educational Specifications for Buildings & Sites), 801.4 (Selection of an Architect), 801.5 (Site Acquisition), 801.6 (Bids and Awards for Construction Contracts), 801.7 (Financing Sites and Construction), and 801.8 (Supervision of Construction) Director Rasmussen moved to approve the second reading and waive the third reading of the policies. Director Denner seconded the motion. Ayes: Ewert, Rosonke, Denner, Rasmussen, and Anderson. Nays: none.

Mike Kennedy informed the School Board that The New Hampton Educational Excellence Foundation is the recipient of a donation from the Andrew (Dick) Heying and Marie E. Heying estate. These funds are to be used to establish scholarships for worthy graduates from New Hampton Community School. These scholarships are to be three thousand (\$3,000) dollars each. Five scholarships are to be awarded annually to graduates of New Hampton Community School chosen by a committee composed of administration and faculty to be based upon criteria od scholastic achievement, character, and economic need.

Director Rosonke moved to approve the following fundraisers: Elementary, Spring Carnival and Boomerang project. Middle School will do the Washington D.C. Raffle and Avon/Hand Lotion Fund raisers. Football will raise fund with the football camp and Saver Card Sales. Volley will raise funds through the Volleyball Camp & NH Fan Apparel Sale with the Youth Volleyball Club. Girls' basketball will raise funds through the Girls' Basketball Camp and Food Sale. Boys' basketball will raise funds through Boys' Basketball Camp & Event Workers for July and Winter Season NH Park & Recreation Tournaments. Wrestling will raise funds with a wrestling raffle with the Youth Wrestling Club. Trapshooting will sell RADA cutlery and trailer advertising. The baseball and softball teams will sell super saver cards. The music department and FFA club will have a Fruit and Food Sale. The Sophomore Class will sell Magazines. The Dance team will conduct a Bake and Rummage Sale, sell cookie dough and a T-shirt Sponsorship and raffle. The flag team will sell cookie dough. Cheerleading will sell Cookie Dough and Spirit Items. The lettermen's club will do their annual lift-a-thon. Director Rasmussen seconded the motion. Ayes: Denner, Ewert, Rasmussen, Rosonke, and Anderson. Nays: none.

Director Rasmussen moved to approve the contract settlement with the support staff. Director Ewert seconded the motion. Ayes: Rosonke, Denner, Ewert, Rasmussen, and Anderson. Nays: none.

Director Rosonke moved to approve a 2% total package increase for the administrative team for a total cost of \$6,381. Director Rasmussen seconded the motion. Ayes: Ewert, Denner, Rasmussen, Rosonke, and Anderson. Nays: none.

Director Ewert moved to approve a 3.45% increase for the central office staff, food service director, and district technology technician for a total cost of \$5,663. Director Rosonke seconded the motion. Ayes: Rasmussen, Denner, Rosonke, Ewert, and Anderson. Nays: none.

Director Rosonke moved to approve the following substitute salaries for FY13: Substitute Teachers-\$98.99/day, Substitute Secretaries \$8.88/hr., Substitute Custodians \$\$8.91/hr., Substitute Paraeducators \$\$8.60/hr., Certified Substitute Paraeducators \$8.60/hr., Paraeducator - Sign Language Proficient \$10.75/hr., Substitute Nurses \$86.28/day, Substitute Cooks \$8.08/hr., Substitute Bus Drivers - Per Route AM or PM \$23.96, Accompanist \$12.34/hr., high school wrestling blood work \$10.00/hr., and middle school wrestling blood work \$25.00 /meet. Director Ewert seconded the motion. Ayes: Rasmussen, Denner, Ewert, Rosonke, and Anderson. Nays: none.

Director Rasmussen moved to approve the 28E sharing agreement with Charles City Schools for half time Spanish teacher. Director Denner seconded the motion. Ayes: Rosonke, Ewert, Denner, Rasmussen, and Anderson. Nays: none.

Director Rasmussen moved to approve the first reading of Board Policy 802.1 – 803.3; Maintenance Schedule, Requests for improvements, Emergency Repairs, Fixed Asset Management System (Fixed Assets Management System Regulations and Fixed Assets Management System Definitions), Buildings and Sites Adaptation for Persons with Disabilities, Parking, Vandalism, and Energy Conservation, Disposition of Obsolete Equipment, Lease, Sale or Disposal of School District Buildings & Sites, and Vacant Facilities. Director Denner seconded the motion. Ayes: Ewert, Rosonke, Denner, Rasmussen, and Anderson. Nays: none.

Enrollment in first grade has increased and Superintendent Jurrens is recommending the District hire an additional teacher. Following discussion of the impact of the increased enrollment Director Rasmussen moved to hire a first grade teacher. Director Ewert seconded the motion. Ayes: Denner, Rosonke, Ewert, Rasmussen, and Anderson. Nays: none.

The third grade sections are also increasing and it was the consensus of the Board that if they continue to increase the Superintendent should consider adding a paraprofessional for the third grade.

The Board set a work session for Monday August 27, 2012, 6:30 pm.

The next regularly scheduled board meeting will be September 10, 2012, 6:30 pm.

Director Ewert moved to adjourn at 8:00 pm. Director Denner seconded the motion. Ayes: Rasmussen, Rosonke, Denner, Ewert, and Anderson. Nays: none.
