

The Board of Directors for the New Hampton Community School District met in regular session, Monday, December 21, 2020 in the High School Media Center. President Rosonke called the meeting to order at 6:30 pm with Director Matthews, Superintendent Jurrens, Board Secretary Roethler, student board members Zoe Worple and Jacob Reicks present. Director Baltes and Denner attended electronically via Zoom. Director Schwickerath was absent.

Director Baltes moved to approve the agenda. Director Matthews seconded the motion. Ayes: Denner, Matthews, Baltes and Rosonke. Nays: none.

Director Baltes moved to approve the consent agenda items. Approve the minutes of the November 16, 2020 regular meeting. Approve the November 2020 monthly financial report and the December 2020 bill listing. Approve Mary Brummond as a paraeducator. Accept the following resignations: Addi Bast, Kristin Farr, Claudia Lopez, Kathy Shekleton and Megan Sobolik. Director Denner seconded the motion. Ayes: Denner, Matthews, Baltes and Rosonke. Nays: None.

Superintendent Jurrens presented more information regarding the school crossing light at the high school and suggested that we move forward with what was recommended by the city and the chief of police. Director Baltes moved to approve the installation of the crossing light. Director Matthews seconded the motion. Ayes: Denner, Matthews, Baltes and Rosonke. Nays: None.

Superintendent Jurrens presented information regarding installation of an additional LP tank at the bus garage. Director Denner moved to approve AgVantage for installing the second tank. Director Baltes second the motion. Ayes: Baltes, Denner, and Rosonke. Nays: none. Director Matthews abstained from the vote.

Director Matthews moved to approve the Spanish Fundraising activity. Director Baltes seconded the motion. Ayes: Baltes, Matthews, Denner, and Rosonke. Nays: none.

Administrator Matthews presented information on behalf of The Small Town Struggles Group on a fundraising activity they would like to do to raise funds to revive the drive-in theater. Director Denner moved to approve the fundraiser. Director Matthews seconded the motion.

Superintendent Jurrens presented information on compensating teachers \$15/per 40-45 min. period who sub during their prep period due to the sub shortage Covid has brought on. Director Matthews moved to approve the additional pay for the remaining 20-21 school year starting January 4th. Director Baltes seconded the motion. Ayes: Baltes, Matthews, Denner, and Rosonke. Nays: none.

Superintendent presented information on allowing Middle School Wrestlers who are not out for basketball to be able to join the high school wrestling practices. This is only allowable for wrestling. Any student who is signed up for basketball will not be able to participate. This would give those athletes who have missed out on a lot of practice and competitions due to the season be cut short some extra practice. Director Baltes moved to approve the Middle School Wrestlers to practice with the high school wrestlers per guidelines stated. Director Denner seconded the motion. Ayes: Baltes, Matthews, Denner, and Rosonke. Nays: none.

It was discussed that superintendent Jurrens mid-year evaluation will take place on January 18, 2021 in closed session.
