## **Board Proceedings**

The Board of Directors for the New Hampton Community School District met in regular session, Monday, March 9, 2015 in the High School Media Center. President Rasmussen called the meeting to order at 6:30 pm with directors Ewert, Baltes, Rosonke, Denner, Board Secretary Ayers, and Superintendent Jurrens present.

Director Denner moved to approve the agenda. Director Rosonke seconded the motion. Ayes: Ewert, Denner, Baltes, Rosonke, and Rasmussen. Nays: none.

President Rasmussen opened the public hearing for the 2015 - 2016 start date and calendar at 6:31 pm. There were no written comments. Dwight Kolthoff presented oral comments at the meeting. After his comments President Rasmussen closed the public hearing at 6:37 pm.

Director Ewert moved to approve the consent agenda items as follows: minutes of the February 9, 2015 regular meeting; February 2015 monthly financial reports; approve the March bill listing. Approve volunteer coaches Paul Ewert (Golf), Wyatt Phillips (Trapshooting), Gayle Poncelet (Trapshooting), and David Schmidt (Trapshooting). Approve the second reading of Policies 411.7 (Support Employee Evaluation), 411.8 (Support Employee Probationary Status), 412 (Employee Compensation and Benefits), 412.1 (Support Employee Compensation), 412.2 (Support Employee Wage and Overtime Compensation), 412.3 (Support Employee Group Insurance Benefits), 412.4 (Support Employee Tax Shelter Programs), 413 (Support Employee Termination of Employment), 413.1 (Support Employee Resignation), 413.2 (Support Employee Retirement), 413.2E (Support Early Retirement), 413.3 (Support Employee Suspension), 413.4 (Support Employee Dismissal), and 413.5 (Support Employee Reduction in Force). Approve the first reading of Policies 605 (Instructional Materials), 605.1 (Instructional Materials Selection), 605.1R (Selection of Instructional Materials), 605.2 (Instructional Materials), 605.3 (Objection to Instructional Materials), 605.3E (Instructions to the Reconsideration Committee), 605.3E2 (Reconsideration of Instructional Materials), 605.3E3 (Sample Letter to Individual Challenging Instructional Materials), and 605.3R1 (Reconsideration of Instructional Materials Regulation).Director Denner seconded the motion. Director Baltes moved to approve the Second reading of Board Policy 202.6 (Student Board Member). Director Rosonke seconded the motion. Ayes: Denner, Ewert, Rasmussen, Baltes, Rosonke. Nays: none.

Director Ewert moved to approve the second reading of Board Policy 603.4 (Multicultural/Gender Fair Education). Director Baltes seconded the motion. Ayes: Denner, Rosonke, Baltes, Ewert, and Rasmussen. Nays: none.

Superintendent Jurrens presented information on the question of diversity in our music program.

Superintendent Jurrens requested the board approve a request for a waiver for an early start date of August 24, 2015 for the 2015 - 2016 school year. Following discussion of the waiver director Rosonke moved to approve the waiver to start the 2015 - 2016 school year on August 24, 2015. Director Ewert seconded the motion. Ayes: Denner, Baltes, Ewert, Rosonke, and Rasmussen. Nays: none.

Director Denner moved to approve sharing of Superintendent Jurrens with the Chickasaw Connections for Drug Free Communities Grant. Director Baltes seconded the motion. Ayes: Rosonke, Ewert, Baltes, Denner, and Rasmussen. Nays: none.

Superintendent Jurrens presented information on the remodel of the bathrooms in the elementary wing. Jurrens recommended the board approve the quote to remodel the two upstairs bathrooms. Director Rosonke moved to remodel the two bathrooms at a cost of \$74,980.47. Director Denner seconded the motion. Ayes: Ewert, Baltes, Denner, Rosonke, and Rasmussen. Nays: none.

Director Denner moved to approve changes to the gym painting (\$5,492.00) and replace curtain closet doors with concrete block (\$2,400.00). Director Rosonke seconded the motion. Ayes: Baltes, Ewert, Rosonke, Denner, and Rasmussen. Nays: none.

Superintendent Jurrens updated the board on the work that Turkey Valley, Howard-Winneshiek, and South Winneshiek have been doing on ideas for working together. Jurrens also presented potential reductions for the 2015 - 2016 school year. Reductions could include the copy para-educator position, bus route, custodian, half time high school math, high school business, half time high school English, high school science, 4<sup>th</sup> grade section, and middle school activities director. Potential these reductions could save the District \$415,017.00. Jurrens also present preliminary information on the 2015 - 2016 budget.

Director Denner moved to set the date and time for the public hearing on the 2015 - 2016 school budget for April 13, 2015 at 6:30 pm. Director Rosonke seconded the motion. Ayes: Ewert, Baltes, Rosonke, Denner, and Rasmussen. Nays: none.

The next regular board meeting will be on April 13, 2015 at 6:30 pm.

Director Denner moved to adjourn at 8:41 pm. Director Baltes seconded the motion. Ayes: Rosonke, Ewert, Baltes, Denner, and Rasmussen. Nays: none.
