

## Board Proceedings

The Board of Directors for the New Hampton Community School District met in regular session, Monday, April 13, 2015 in the High School Media Center. President Rasmussen called the meeting to order at 6:30 pm with directors Ewert, Baltes, Rosonke, Denner, Board Secretary Ayers, and Superintendent Jurrens present.

Director Denner moved to approve the agenda. Director Baltes seconded the motion. Ayes: Ewert, Denner, Baltes, Rosonke, and Rasmussen. Nays: none.

President Rasmussen opened the public hearing for the 2015 – 2016 School Budget at 6:31 pm. There were no written or oral comments. President Rasmussen closed the public hearing at 6:32 pm.

Director Rosonke moved to approve the 2015 – 2016 School Budget as published. Director Baltes seconded the motion. Ayes: Ewert, Denner, Baltes, Rosonke, and Rasmussen. Nays: none.

Director Denner moved to approve the consent agenda items as follows: minutes of the March 9, 2015 regular meeting; March 2015 monthly financial reports; approve the April bill listing. Accept Bill Boyd's resignation as the assistant varsity football coach. Appoint coaches; Jordan Richards (7<sup>th</sup> boys Track), Ryan Huffman (8<sup>th</sup> boys track), Jeff Eichenberger (assistant varsity softball), Lexie Kennelly (assistant varsity volleyball), Alex Swanziger (8-9 baseball), and volunteer coach Tarron Hansen (Trapshooting). Approve the second reading of Policies 605 (Instructional Materials), 605.1 (Instructional Materials Selection), 605.1R (Selection of Instructional Materials), 605.2 (Instructional Materials Inspection), 605.3 (Objection to Instructional Materials), 605.3E (Instructions to the Reconsideration Committee), 605.3E2 (Reconsideration of Instructional Materials), 605.3E3 (Sample Letter to Individual Challenging Instructional Materials), and 605.3R1 (Reconsideration of Instructional Materials Regulation). Approve the first reading of Policies 200 (Legal Status of the Board of Directors), 200.1 (Role of the Board of Directors), 200.2 (Organization of the Board of Directors ), 200.3 (Powers of the Board of Directors), 200.4 (Responsibilities of the Board of Directors), 201 (Board of Directors' Elections), 202 (Board of Directors Members), 202.1 (Qualifications), 202.2 (Oath of Office), 202.3 (Term of Office), 202.4 (Vacancies), and 202.5 (Individual Authority). Approve placement agreements with Luther College, Wartburg College, and University of Northern Iowa. Director Ewert seconded the motion. Ayes: Baltes, Rosonke, Denner, Ewert, and Rasmussen. Superintendent Jurrens provided information on the settlement with the New Hampton Education Association. After discussion director Baltes moved to approve the contract with the New Hampton Education Association for the 2015 – 2016 school year. Director Ewert seconded the motion. Superintendent Jurrens provided information on the settlement with the New Hampton Education Association Support Group. Superintendent Jurrens shared information on the middle school band enrollment and anticipated need for instruments. There were two quotes submitted, West Music and Rieman Music. Each quote was a four year plan to replace middle school band instruments. Superintendent Jurrens recommended the Board to accept the quote from Rieman Music for \$83,345.96. Director Rosonke moved to accept the quote of Rieman Music for \$83,345.96. The first year cost will be \$21,945.96, second year \$21,364.00, third year \$20,365.00, and fourth year \$19,671.00. Director Baltes seconded the motion. Ayes: Denner, Ewert, Baltes, Rosonke, and Rasmussen. Nays: none.

Judy O'Donohoe requested help with the Odyssey of the Mind team that will attend the World Competition in Michigan. Jurrens informed the board that we have given financial help in the past and recommended the Board approve a \$1,000.00 to offset cost of the competition. Director Baltes moved to approve the contract for APL associates for October 5, 2015 for a cost \$3,000 plus travel expenses. Director Denner seconded the motion. Ayes: Ewert, Rosonke, Denner, Baltes, and Rasmussen.

Superintendent Jurrens presented a request from Mrs. Anderson to conduct a retreat for the 5th and 8th grade classes for a total cost of \$5,090.00. Director Rosonke moved to approve Youth Frontiers to conduct a retreat for middle school students for a cost of \$5,090.00. Director Ewert seconded the motion. Ayes: Baltes, Denner, Ewert, Rosonke, and Rasmussen. Nays: none.

Superintendent Jurrens presented information on the Daktronics equipment the district owns and a service agreement proposal. Following discussion director Denner moved to approve the Gold Level Service Agreement for a yearly cost of \$1,485.00. Director Rosonke seconded the motion. Ayes: Ewert, Baltes, Rosonke, Denner, and Rasmussen. Nays: none.

Director Denner moved to approve the Orchestra Sharing Agreement with Charles City Schools. Director Rosonke seconded the motion. Ayes: Baltes, Ewert, Rosonke, Denner, and Rasmussen. Nays: none.

Superintendent Jurrens updated the Board on potential options for sharing positions with neighboring districts.

Superintendent Jurrens reviewed the FY2014 Audit.
