Board Proceedings

The Board of Directors for the New Hampton Community School District met in regular session, Monday, September 14, 2015 in the High School Media Center. President Rasmussen called the meeting to order at 6:30 pm with directors Rosonke, Baltes, Denner, Ewert, Superintendent Jurrens, and Board Secretary Ayers.

Director Denner moved to approve the agenda. Director Baltes seconded the motion. Ayes: Ewert, Rosonke, Denner, Baltes, and Rasmussen. Nays: none.

Director Ewert moved to approve the consent agenda items: minutes of the August 10, 2015 regular session, the August 20, 2015 special meeting, approve the August 2015 monthly financial report and the September 2015 bill listing. Appoint Jacob Hackman (regular bus driver). Approve Nicole Avenson (middle school cheerleading), Jason Speltz (head individual speech), and Karen Kayser-Kemp (high school annual). Approve volunteer coaches Cassie Hackman (volleyball), Mitch Gage (music/drama), and Bobby Schwickerath (dance). Secretary Ayers reviewed the annual treasurer's report. Following discussion of the report director Denner moved to accept the report as presented. Director Baltes seconded the motion. Ayes: Ewert, Baltes, Denner, Rosonke, and Rasmussen. Nays: none.

Superintendent Jurrens presented the Abstract of Election from the September 8, 2015 election. Vote for New Hampton School Board District No. 1 for a term of four (4) years. Jay Matthews received Two hundred forty-five (245) votes. There was a scattering of Twenty-Three (23) votes for a total of Two Hundred sixty-eight (268) votes. Therefore; Jay Matthews was duly elected for the office of New Hampton School Board Director District No. 1 for the term of four (4) years. Vote for New Hampton School Board District No. 2 for a term of four (4) years. Nathaniel W. Schwickerath received one hundred sixty-five (165) votes. Write-in Donald J. Njus received ninety-seven (97) votes. Write-in MaryBeth Kamrath-Ovel received seventy-two (72) votes. There was a scattering of two (2) votes. Therefore; Nathaniel W. Schwickerath was duly elected for the office of New Hampton School Board Director District No. 2 for the term of four (4) years. Director Rosonke moved to approve the Abstract. Director Denner seconded the motion. Ayes: Ewert, Baltes, Denner, Rosonke, and Rasmussen. Nays: none.

Director Denner moved to adjourn the FY 2015 school board at 6:45 pm. Director Baltes seconded the motion. Ayes: Baltes, Denner, Rosonke, Ewert, and Rasmussen. Nays: none.

Vice President Rosonke presented plaques and lifetime passes to Jennifer Ewert (four years' service) and Tom Rasmussen (seven years' service) and thanked them for their service to the New Hampton Community School Board.

Secretary Ayers called the 2015-2016 School Board to order at 7:27 pm.

Secretary Ayers administered the oath of office to the newly elected board members Jay Matthews and Nathaniel Schwickerath.

Secretary Ayers asked for nominations for president. Director Baltes nominated Rosonke for president. Director Denner seconded the nomination and asked to close nominations for president. Secretary Ayers declared nominations closed. The board opted for a voice vote and Rosonke was unanimously elected as president of the New Hampton School Board.

Secretary Ayers conceded the chair to president elect Rosonke. President Rosonke asked for nominations for vice-president. Director Matthews nominated Baltes and requested nominations to be closed. Director Schwickerath seconded the motion. The board unanimously elected Baltes as vice-president.

Director Denner seconded the motion. Ayes: Schwickerath, Matthews, Denner, Baltes, and Rosonke. Nays: none.

Director Denner moved to appoint Baltes as the IASB Legislative Action Network Representative. Director Schwickerath seconded the motion. Ayes: Denner, Baltes, Schwickerath, Matthews, and Rosonke. Nays: none.

Director Schwickerath moved to appoint Denner as the IASB Delegate Assembly Representative. Director Matthews seconded the motion. Ayes: Denner, Baltes, Matthews, Schwickerath, and Rosonke. Nays: none.

Director Schwickerath moved to appoint Denner, Rosonke, and Baltes to the negotiations committee. Director Matthews seconded the motion. Ayes: Denner, Baltes, Matthews, Schwickerath, and Rosonke. Nays: none.

Director Schwickerath moved to appoint Rosonke and Matthews serve on the transportation committee. Director Denner seconded the motion. Ayes: Matthews, Denner, Schwickerath, Baltes, and Rosonke.

Director Matthews moved to appoint Schwickerath and Denner to serve on the facilities committee. Director Denner seconded the motion. Ayes: Schwickerath, Denner, Matthews, Baltes, and Rosonke. Nays: none.

Superintendent Jurrens recommended the Board to approve Beth Hanson as the school attorney. Director Baltes moved to appoint Beth Hanson as school attorney. Director Schwickerath seconded the motion. Ayes: Denner, Baltes, Schwickerath, Matthews, and Rosonke. Nays: none.

Superintendent Jurrens recommended the Board to appoint Jurrens as the chief negotiator and appoint Steve Weidner as the backup. Director Denner moved to appoint Jurrens as chief negotiator and Steve Weidner as backup negotiator. Director Schwickerath seconded the motion. Ayes: Baltes, Matthews, Schwickerath, Denner, and Rosonke. Nays: none.

Superintendent Jurrens recommended the board approve the following substitute salaries; teachers (\$105/day), secretaries (\$9.28/hr.), custodians (\$9.31/hr.), paraeducators (\$9.00/hr.), nurse (\$95/day), cooks (\$8.48/hr.), bus drivers (\$30/trip), accompanist (\$12.34/hr.), hs wrestling, blood (\$10/hr.), ms wrestling, blood (\$25/event), certified paraeducators (\$9.48), sign language paraeducators (\$11.15/hr.), and activity trip (\$12.00/hr.) Director Denner moved to increase the substitute salaries for FY15 as recommended. Director Matthews seconded the motion. Ayes: Baltes, Schwickerath, Matthews, Denner, and Rosonke. Nays: none.

Superintendent Jurrens recommended the board approve Vo-Ag instructor Russ permission to take a group of students to the National FFA Convention. Director Matthews moved to grant permission to attend the FFA Convention. Director Denner seconded the motion. Ayes: Baltes, Schwickerath, Denner, Matthews, and Rosonke. Nays: none.

Superintendent Jurrens presented information on the special education deficit for FY15 school year. He recommended the board request allowable growth for the deficit. Director Denner moved to approve a request to the School Budget Review Committee for allowable growth in the amount of \$ \$359,987.58 for the special education deficit. Director Baltes seconded the motion. Ayes: Schwickerath, Matthews, Baltes, Denner, and Rosonke. Nays: none.

Superintendent Jurrens recommended the board approve the purchase of thirty Chromebooks as the lower elementary is making good use of their available technology. They would like additional Chromebooks to supplement the IPads and MacBook's they already have. The cost will be \$12,045 and will come out of the SAVE Funds. Jurrens reported that we are nearing 1:1 in devices at the elementary level, which is a good thing as our staff is looking for this and it is the teachers that are making the request. Director Denner moved to approve the purchase of the Chromebooks. Director Matthews seconded the motion. Ayes: Schwickerath, Baltes, Matthews, Denner, and Rosonke. Nays: none.

Work session is scheduled for Monday, September 8, 2015.

Next regular board meeting will be Monday, October, 8, 2015.
