Board Proceedings

The Board of Directors for the New Hampton Community School District met in regular session, Monday, December 14, 2015 in the High School Media Center. President Rosonke called the meeting to order at 5:30 pm with directors Baltes, Denner, Schwickerath, Mathews, Superintendent Jurrens, Student Representative Samantha Reicks, and Board Secretary Ayers.

Director Denner moved to approve the agenda as published. Director Matthews seconded the motion. Ayes: Baltes, Denner, Matthews, Schwickerath, and Rosonke. Nays: none.

Director Baltes moved to approve the consent agenda items: minutes of the November 9, 2015 regular session, the November 16 and November 17, 2015 special meeting, approve the November 2015 monthly financial report and the December 2015 bill listing. Appoint Lisa Poole (High School Cheerleading Coach). Approve Jim Gorman and Melissa Drewelow STAR mentors. Approve the second reading of Board Policies 700 (Purpose of Noninstructional and Business Services), 701 (Financial Accounting System), 701.1 (Fiscal Year), 701.2 (Depository of Funds), 701.3 (Classification of Accounts), 701.4 (Transfer of Funds), 701.41 (Governmental Accounting Practices and Regulations), and 701.5 (Financial Records). Approve the first reading of Board Policies 702 (Cash in School Buildings), 702.R1 (Gate Receipts), 703 (Budget), 703.1 (Budget Planning), 703.2 (Spending Plan), 704 (Revenue), 704.1 (Local - State - Federal - Miscellaneous Revenue), 704.2 (Sale of Bonds), 704.3 (Investments), 704.4(Gifts - Grants - Bequests), and 704.5 (Student Activities Fund). Director Matthews seconded the motion. Ayes: Schwickerath, Matthews, Denner, Baltes, and Rosonke. Nays: none.

Superintendent Jurrens reviewed bids for a new dish washer in the high school kitchen and recommended purchasing the Hobart CL44E from Central Restaurant Products for a cost of \$17,199.67. Director Denner moved to purchase the Hobart and use SAVE Funds to pay for the dishwasher. Director Schwickerath seconded the motion. Ayes: Baltes, Matthews, Schwickerath, Denner, and Rosonke. Director Denner moved to reassign Cory McDonald as the varsity baseball coach for the summer of 2016. Director Baltes seconded the motion. Ayes: Schwickerath, Matthews, Baltes, Denner, and Rosonke. Nays: none.

The Board discussed joining the New Hampton Chamber of Commerce. Director Matthews requested a board policy to be developed addressing the membership. Director Matthews moved to join the New Hampton Chamber of Commerce at the White Ribbon level for \$200.00. Director Denner seconded the motion. Ayes: Schwickerath, Baltes, Denner, Matthews, and Rosonke. Nays: none.

The board discussed repairs needed to the three stall garage at the 206 West Main Street location. Following discussion they tabled any decision until the January board meeting.

Members of the Board shared thoughts on the School Board Convention.

Superintendent Jurrens shared information on the Attendance Center Rating system as developed by the Department of Education.

Because of time constraints President Rosonke asked to table the Superintendent's mid-year evaluation until January and the board members agreed.
