Board Proceedings

The Board of Directors for the New Hampton Community School District met in regular session, Monday, December 19, 2016 in the High School Media Center. President Rosonke called the meeting to order at 5:30 pm with directors Denner, Schwickerath, Matthews, and Baltes, Superintendent Jurrens, and Board Secretary Ayers present. Student member Holthaus was absent.

Director Denner moved to approve the agenda. Director Matthews seconded the motion. Ayes: Baltes, Matthews, Schwickerath, Denner, and Rosonke. Nays: none.

Director Baltes moved to approve the consent agenda items: minutes of the November 21, 2016 regular session, the November 17, 2016 special session, and the December 8, 2016 special session. Approve the November 2016 monthly financial report, and the December 2016 bill listing. Approve the second reading of Board Policies 904.5 (Distribution of Materials), 904.5R1 (Distribution of Materials Regulation), 905 (Community Activities Involving Students), 905.1 (Transporting Students in Private Vehicles), 905.2 (Advertising and Promotion), 905.3 (Use of School District Facilities & Equipment), 905.3E1 (Community Use of School District Buildings & Sites & Equipment Application Form), 905.3E2 (Community Use of School District Facilities Regulation & Equipment Regulation), 905.3R2 (Community Use of School District Buildings & Site & Equipment Fees Schedule), and 905.4 (Smoke-Free Environment). Approve the first reading of Board Policies 500 (Objectives for Equal Educational Opportunities for Students), 501 (Student Attendance), 501.1 (Resident Students), 501.2 (Nonresident Students), 501.3 (Compulsory Attendance), 501.4 (Entrance – Admissions), 501.5 (Attendance Center Assignment), 501.6 (Student Transfers In), and 501.7 (Student Transfers Out or Withdrawals). Director Denner seconded the motion. Ayes: Schwickerath, Matthews, Denner, Baltes, and Rosonke. Nays: none.

Superintendent Jurrens reported he had identified 11 individuals who would be eligible for early retirement (at least 55 and with 15 years of experience in the district). Jurrens has heard from some teachers who have expressed a desire to delay retirement for two or more years. Jurrens suggested the board, if they decided to do something; they may want to look at something over two years. Jurrens suggested setting a maximum number of early retirements for each year. The board discussed early retirement and by consensus the Board decided to table the discussion until the January board meeting.

The Board discussed the resolution ordering a special election on the issuance of \$19,415,000 general obligation school bonds. The President of the Board called the meeting together and stated that a Petition had been filed purporting to be signed by eligible electors of the School District numbering at least 25% of those voting at the last election of school officials. The Petition requests that an election be called on the issuance of bonds in an amount not to exceed \$19,415,000, to provide funds to build, furnish, and equip additions to the High School facility for Middle School educational areas, with support and shared use areas including food service, vocational technologies, and multi-purpose/gymnasium spaces, and to remodel, repair and improve the facility and site.

The President submitted the Petition to the Board which examined the Petition. 351 qualified electors voted at the last election of school officials; the number of eligible electors who have signed the petition is 151.

Director Baltes introduced the following Resolution and moved its adoption. Director Matthews seconded the motion to adopt and, on roll call, the vote was: Ayes: Matthews, Denner, Schwickerath, Baltes, and Rosonke. Nays: none. The President declared the Resolution adopted as follows:

WHEREAS, there has been filed with the President of this Board a Petition of eligible electors of this School District asking that an election be called to submit the question of contracting indebtedness and issuing bonds of the School District in an amount not to exceed \$19,415,000 to provide funds to build, furnish, and equip additions to the High School facility for Middle School educational areas, with support and shared use areas including food service, vocational technologies, and multi-purpose/gymnasium spaces, and to remodel, repair and improve the facility and site; and

WHEREAS, this Board has examined the Petition and finds that it is signed by eligible electors of the School District numbering at least 25% of those voting at the last election of school officials and that the purposes set forth in the petition cannot be accomplished within the limit of one and one-quarter percent of the assessed value of the taxable property in the School District; and

WHEREAS, the proposal for the issuance of Bonds or any other proposal incorporating any portion of it has not or will not have been submitted to the qualified electors of the School District for a period of at least six months prior to the date of election being called in these Proceedings;

NOW, THEREFORE, IT IS RESOLVED BY THE NEW HAMPTON COMMUNITY SCHOOL DISTRICT, IN THE COUNTIES OF CHICKASAW AND HOWARD, STATE OF IOWA:
