

## Board Proceedings

The Board of Directors for the New Hampton Community School District met in regular session, Monday, December 20, 2019 in the High School Media Center. President Rosonke called the meeting to order at 6:30 pm with directors Denner, Matthews, Schwickerath, Baltes, Superintendent Jurrens, acting Board Secretary Roethler.

Director Baltes moved to approve the agenda. Director Schwickerath seconded the motion. Ayes: Denner, Baltes, Matthews, Schwickerath, and Rosonke. Nays: none.

Director Denner moved to approve the consent agenda items with the addition of adding Lisa Rude as Head Varsity Softball coach. Director Baltes seconded the motion. Ayes: Denner, Matthews, Schwickerath, Baltes and Rosonke. Nays: None.

Director Matthews moved to approve the Board Policy 711.10 Bus Seat Belt Policy. Director Baltes seconded the motion. Ayes: Denner, Schwickerath, Matthews, Baltes and Rosonke. Nays: none.

Secretary Ayers reviewed the annual treasurer's report. Following discussion of the report director Schwickerath moved to accept the report as presented. Director Matthews seconded the motion. Ayes: Baltes, Matthews, Denner, Schwickerath, Rosonke. Nays: none.

Superintendent Jurrens presented the Abstract of Election from the November 5, 2019 election. Vote for New Hampton School Board District No. 1 for a term of four (4) years. Jay Matthews received Nine Hundred and Eighty-Eight (988) votes. There was a scattering of Eleven (11) votes for a total of Nine Hundred and Ninety-Nine (999) votes. Therefore; Jay Matthews was duly elected for the office of New Hampton School Board Director District No. 1 for the term of four (4) years. Vote for New Hampton School Board District No. 2 for a term of four (4) years. Nathaniel W. Schwickerath received Nine Hundred and Ninety-four (994) votes. There was a scattering of Seven (7) votes for a total of One Thousand and One (1001) votes. Therefore; Nathaniel Schwickerath was duly elected for the office of New Hampton School Board Director District No. 2 for the term of four (4) years.

Director Baltes moved to approve the Abstract of Votes. Director Denner seconded the motion. Ayes: Baltes, Denner, Schwickerath, Matthews, and Rosonke. Nays: none.

Director Baltes moved to adjourn the FY 2019 school board at 6:52pm. Director Denner second the motion. Ayes: Matthews, Schwickerath, Denner, Baltes, and Rosonke. Nays: none.

Acting Secretary Roethler called the 2019-2020 School Board to order at 6:52 pm.

Acting secretary Roethler administered the oath of office to the newly elected board members Jay Matthews and Nathaniel Schwickerath.

Acting Secretary Roethler asked for nominations for president. Director Denner nominated Rosonke for president. Director Matthews seconded the nomination and asked to close nominations for president and cast a unanimous vote for Joe Rosonke. Baltes seconded the motion. Ayes: Schwickerath, Baltes, Matthews, Denner, and Rosonke. Rosonke was unanimously elected as president of the New Hampton School Board.

Acting Secretary Roethler conceded the chair to president elect Rosonke. President Rosonke asked for nominations for vice-president. Director Schwickerath nominated Baltes and requested nominations to be closed. Director Matthews seconded the motion. Ayes: Schwickerath, Baltes, Matthews, Denner, and Rosonke. The board unanimously elected Baltes as vice-president.

The board reviewed the pay applications of contractors for the school construction project. Director Matthews moved to approve the pay applications with the exception of subtracting \$2,190.00 from the Seating & Athletic Facility Enterprises, LLC pay app. Director Denner seconded the motion. Ayes: Schwickerath, Baltes, Matthews, Denner and Rosonke. Nays: none.

Director Baltes moved to approve the First Reading Board Policies 900-903. Director Matthews second the motion. Ayes: Denner, Schwickerath, Matthews, Baltes and Rosonke. Nays: none.

Director Matthews moved to approve that committee assignments stay the same as last year. Director Denner seconded the motion. Ayes: Baltes, Schwickerath, Matthews, Denner, and Rosonke. Nays: none.

Director Denner moved to appoint Steve Weidner as the school Attorney. Director Baltes seconded the motion. Ayes: Denner, Matthews, Baltes, Schwickerath, and Rosonke. Nays: none.

Director Schwickerath moved to appoint Jay Jurrens as the chief negotiator. Director Denner seconded the motion. Ayes: Baltes, Matthews, Denner, Schwickerath, and Rosonke. Nays: none.

Superintendent Jurrens presented the Snow Removal Bid. One bid was received, Jurrens recommended accepting the bid of Steve Smith. Director Denner moved to accept the bid of Steve Smith. Director Schwickerath seconded the motion. Ayes: Schwickerath, Matthews, Baltes, Denner, and Rosonke. Nays: none.

Ag Instructor James Russ presented information on STEM BEST Grant and the purchase of a 2020 Kawasaki Mule. Director Baltes moved to approve the purchase of the 202 Kawasaki Mule. Director Matthews seconded the motion. Ayes: Denner, Baltes, Rosonke, Matthews. Nays: Schwickerath.

Superintendent Jurren’s presented information on the request of Fidelity Bank using our logo on their Debit Cards. The school will receive five dollars for each debit card issued with our logo.
