## **SBRC SE Admin request**

Districts who participate in the Lied Center Consortium have the opportunity to request special education administrative costs. Attached to this email are two files associated with the annual request to the School Budget Review Committee (SBRC). Districts are <u>not</u> required to make this request.

The first attachment is the SBRC administrative costs file that shows the dollar amount each District may request. Your individual school district amount is determined by taking the total administrative salary with FICA/IPERS divided by the total number of students enrolled in the Lied Center students from your school district attending the Lied Center program.

The second SBRC administrative cost file is a suggested generic Board motion you can use to approve your district's request to the SBRC. Please include the dollar amount in your motion, and please <u>make sure</u> that your minutes reflect the actual dollar amount you are requesting. If the exact dollar amount is not included in your school board minutes, your request will be denied.

As a reminder you are applying for special education administrative costs for the **2023/24 school year**. Special education administrative cost requests are required to be made a year in advance. Because we need to apply in advance, we use the actual administrative salary with FICA/IPERS for the current (2022/23) school year. Requests to the SBRC for administrative special education costs are to be done annually.

Please email me a copy of your school board minutes stating approval of your application no later than January 27, 2023. I will compile all approved requests received and submit a joint request on behalf of all Lied Center Consortium member schools.
