The New Hampton Community School District Board of Education invites current high school students to apply to become the 2015-2016 Student School Board of Education Member. One student will be selected to serve as a Student Board Member.

Please read the information below prior to completing the application form to be a Student Board Member.

General Information:

- 1. The application deadline is June 1st.
- 2. The applicant must be a member of the student body of New Hampton High School.
- 3. The term of office shall be from the Regular September school board meeting until the last Regular Board Meeting in May in the school year they are appointed to the position.
- 4. The Student Board Member will be given time on each School Board agenda to speak regarding student concerns, curriculum, and activities.
- 5. The student representative shall have the following duties:
 - a. The privilege and obligation to be present at all New Hampton School District Board open meetings.
 - b. The privilege of submitting items for discussion on the Board Agenda except those items relating to personnel.
 - c. He/she will be called upon to reflect opinions of students of the school and/or present a report on a specific issue to the Board.
 - d. Responsible for communicating Board decisions and information to the school and student body.
 - e. Responsible for presenting recommendations from the student body or the student government of the school to the School Board.
- 6. The Student Government and/or the building principal may ask that a student be recalled from his/her position as Student Board Member for neglecting his/her duties as a representative of the student body. Such circumstances would include, but are not limited to, failure to attend board meetings on a consistent basis, a good conduct violation, or any behavior that reflects negatively on the student body.
